DO NOT FORGET - Three Important Things to Find Out

1. Current Technological Infrastructure and Pain Points:

Question: "Can you describe your current coding and billing technology setup? What specific challenges are you encountering?"

Purpose: This will help you identify gaps where Fathom's solutions can provide immediate value.

2. Strategic Priorities for Operational Efficiency:

Question: "What are your top priorities for enhancing operational efficiency over the next year? How are you planning to achieve these goals?"

Purpose: Understand where Novant is focusing its efforts so you can align Fathom's offerings with their strategic objectives.



3. Decision-Making Process and Stakeholders:

Question: "Can you walk me through your decision-making process for implementing new technologies? Who are the key stakeholders involved?"

Purpose: Identify the influencers and decision-makers, ensuring you engage all relevant parties in subsequent discussions. Start to identify "mobilizers" – ask the participants in this call to make introductions to other players.

DO NOT FORGET - Three Important Things to Articulate

Purpose: Emphasizing the cost savings and efficiency gains highlights the immediate financial and operational benefits of adopting Fathom's technology.

Message: "Our solutions are HIPAA and SOC 2 compliant, employing real-time auditing to ensure continuous compliance and data security. In light of recent cyber threats, our robust security measures can provide peace of mind and protect sensitive patient data."
